“Unlimited free night call facility from BSNL CDMA Post-paid fixed/limited connections to Landline & Mobile of BSNL Network i.e. On Net only shall be revised from existing “9 PM to 7 AM” to “10.30 PM to 6 AM” w.e.f 01-02-2018.”

2. Above tariff revision is applicable for shall be applicable for post-paid Fixed/limited CDMA Customers.
