Sub: Common order dated 08.06.2018 of Hon'ble High Court, Hyderabad in WP Nos. 18958, 19232, 23127, 23135 & 25300 of 2016 in the matter of Md. Ghouse and others ---Approval for implementation thereof.

Sir,

I am directed to refer to this office letter of even No. dated 23.07.2018 vide which directions have been given for filing of SLP against the common order dated 08.06.2018 of the Hon'ble High Court, Hyderabad in the aforesaid matter.

2. The matter has been reviewed afresh in consultation with the Legal branch of BSNL, CO and in supersession of previous instructions given vide this office letter of even no. dt. 23.07.2018, referred above, approval of the Competent Authority is hereby conveyed for implementing the common order dated 08.06.2018 of the Hon'ble High Court, Hyderabad in the aforesaid WPs in respect of Petitioners only, as a special case.

3. Further, following actions in this case should also be taken:

(a) Clarification issued by your office vide point no.2 of your office letter No. TA/RE/22-10/06 dated 18.01.2007 to all the SSAs providing that the officials who passed their Graduation without obtaining 10+2 qualification are eligible to appear in the LDCE for TTA under 40% quota should be withdrawn with immediate effect.

(b) Circumstances leading to issue of such clarification may be got investigated and suitable disciplinary action against the erring officers may be taken under intimation to this office.

(c) Verification of the Graduation Degrees acquired by the Petitioners may be got done from the respective Universities and their recognition may also be confirmed from concerned regulatory body i.e. UGC etc. and if delay is expected then in order to avoid contempt of Hon'ble Court, the petitioners may be provisionally promoted as JEs after imparting requisite training which will be subject to verification of their degree certificate.

4. It is prudent to mention that the instructions issued by this office vide letter No. 250-3/2015-EStt.-III dated 18.05.2015 providing that candidates possessing higher qualifications directly without 10th and 10+2 standard are not eligible to appear in the LICE for TTA will hold good for future examinations.

Necessary action may be taken and compliance reported to this office with regard to status of the disciplinary proceedings, withdrawal of order dated 18.01.2007 and implementation of the common order dated 08.06.2018.
